Trader stand request/ Information

Please note all requests to trade are subject to approval by BPF Limited. BPF is run by 7 volunteers and we are a Not for profit business. We have a preference for artisan traders who make/sell their own stock rather than mass produced items. Pirate, marine themed stock etc. We also prefer small business rather than Multi nationals etc. All about helping local businesses. Stall needs to have Pirate decorations, with you dressed as Pirates as best as you can.

Please note that just two of us, Pirate Luna May & Lady Scarlet, deal with all of the Traders, so please be patient if we do not respond right away to you.

Costs, the most important bit for most of you.

Area A nearest to main stage, busiest area etc, see attached map. This fee covers all 3 days. So the most expensive pitch is in Area A. Area A will only be available for dry goods Traders if the bars do not use that space.

Please indicate whether you trade inside your Gazebo, ie like a shop or from the outside only as this will help us plan the spaces better.

These prices are for all 3 days the festival is on, no price reduction if you only trade for 1 or 2 days. Other sizes may be available, please ask. You must provide your own Gazebo, tables etc and suitable weights for a hard surface. You must also only trade within your designated space. Suitable risk assessment must be provided promptly if requested. Please note generators are not normally permitted.

We do need a copy of your Public Liability Insurance that will be current during the event.

All alcohol & food outlets are Price on application. Separate application form, not this one.

A limited number of stalls may be able to be supplied with electric, please ask when booking. Any special requirements, please state on the application form. We make no promises that we can accommodate your requests. We reserve the right to charge for the disposal of any rubbish etc left on your pitch.

We prefer traders who deal in both cash and card. If you are CARD payment only, please display a large prominent sign to that effect. Please note many visitors only deal in cash. Also note due to numbers attending the signal for your card machine may not always work.

Payment 50% non refundable deposit required at time of booking. We will send you an invoice. Balance due by 31st January 2025. This allows us time to include your details on our website, get the Map printed etc. If you pay after January, but before 28th February you may still be able to trade, but your details may not be on our website etc. Your booking will be confirmed by us once you have paid the sum in full. Failure to pay the balance voids the booking, meaning you will not be able to trade. We had a waiting list for 2024, and expect the same for 2025.

Mon 10 00 til 16.00

Terms and conditions

Most of you will be able to set up before the roads are closed, of course if the general security threat increases this may change, and is outside of our control. If you wish to trade on Middle Street you are unlikely to be able to set up until the road is closed. Please note Middle street is the main access for Bands and emergency services, so one traffic lane MUST be clear of obstructions at all times.

Security

You are responsible for your own property and equipment. Brixham Pirate festival Ltd (BPF) is not liable for any loss or damage to your property. An Event security team is on duty during the fixed hours (road closure times) of the festival. If you have any concerns re suspicious activity etc please raise it with them or the Police who will be present. Your pitch must be left clean and tidy. Any damage to council property will be charged to the appropriate person.

Health and safety.

Once the roads are closed, no vehicles (except by exception, decision made by us & security) are allowed to move inside the road closed zone. This applies to cars belonging to traders and staff, promotional vehicles etc which will need to be parked in suitable car parks. No generators are allowed on site, except by exception. Due to road closures, you may not be able to set up until 10.00, depending on location with the roads being reopened at 18.00. So, by the specific time the road closure ends you need to be dismantled to the point that traffic can flow freely. Please park tidily while loading/unloading, do not block the road. We reserve the right to evict any stall holder causing a nuisance or not adhering to correct procedures. Please note Brixham harbour is a working Port.

Cancellations, exceptional circumstances

In the event that Brixham Pirate Festival is postponed, cancelled or abandoned, or in the event of failure or curtailment of supplies, services, or facilities afforded to traders whether this is due to acts of God, strikes, lockouts, or any other circumstances whether foreseeable or not, BPF will in not be liable for any losses, expenditure sustained by traders. If the event is cancelled refunds can only be considered once all costs incurred by BPF are paid.

All exhibitors are required to comply with the directions of the organisers, marshals, security etc, anyone not doing so or causing annoyance or unacceptable behaviour may be expelled from the event.

We aim to inform you of your location approximately 2 weeks ahead of the Festival, this of course may have to change due to circumstances beyond our control. This is only so you can see where you are likely to be located. It is not an invitation for you to ask for another Location.

GDPR

We, BPF limited, will not share your details with any other body, festival etc. We may have to release your details to the relevant Authorities in order to comply with UK legislation, Investigations. If we do so, we will aim to inform you, if we are allowed to do so. We may retain your details for up to 6 years.

Food traders, we do forward the local authority food safety form to Torbay council
